

Kritters Campground General Policies

Check in/Check out: **Campground check in is at 2:00 PM and check out is at 11:00 AM. Lodging check in is at 3:00 PM and check out is at 11:00 AM.** Early check in and late check out must be requested in advance and will be approved based on availability. Failure to vacate the campsite or lodging by 11:00 AM or the agreed upon late check out time will result in additional charges. Anyone planning to arrive after 8:00 PM should make prior arrangements with the office. Kritters Campground is in the Eastern time zone.

Depending on availability, temporary parking (not on the campsite) may be provided at no charge on the day of arrival or departure to allow you to enjoy the area a little longer. Please request temporary parking in advance with the office.

Campsite: Each campsite has a maximum occupancy of 8 people, including no more than 4 adults. Day Visitors must check in at the camp office. The cost per visitor is \$5 per day and must leave by quiet time. Each campsite is allowed no more than 2 vehicles or trailers in addition to one camping unit. Overflow parking is available for \$5 per vehicle or trailer per day. Inquire at the office. A tent or screen room may be allowed on an RV site with prior permission and specified location. No dumping of gray water or sewer on the ground at any time. Please contact the office immediately if a spill occurs.

Lodging: No pets are allowed in any of the lodging. For the safety of our younger guests, children under 6 are not permitted on the top bunk, and the recommended age is 10 and up.

Rugs & Mats: In order to preserve the grass and the appearance of the campsites **NO RUGS OR MATS** of any size are permitted on the ground.

Campfires: No outside firewood is allowed. Firewood must be purchased at the office. Campfires must be kept in the fire rings. Fire rings may not be moved without prior permission. Do not leave fires unattended. No foraging for firewood or cutting/breaking of trees allowed. Do not throw trash or cigarette butts in the fire rings. Fire rings are cleaned after each visitor, and a \$20 fee will be charged for trash left in the fire ring.

Quiet Time: **Quiet time is from 11:00 PM until 7:00 AM.** Please be respectful to your fellow campers.

Speed Limit: **The park speed limit is 5 MPH and is strictly enforced.**

Damage: Damages to lodging or campsites will be repaired at the camper's expense.

Water Usage: Washing of campers, ORVs, vehicles, bicycles, boats and camping supplies is not allowed.

Pets Policy: We are a pet-friendly campground. Pets must be kept on a leash and may not be tied to trees. Pets may not be left unattended outside of your camper. Please use good judgment when leaving a pet in your camper while you are away. The nature trail is a great option for walking your dog. Please plan ahead and clean up after your pet. Failure to clean up after your pet will result in a \$10 charge per occurrence.

Pets are not allowed in the office/store, lodging, laundry facilities, restrooms, or pavilion. Kritters Campground is not responsible for and will hold accountable the pet owner for any injury or damage caused by pet. We reserve the right to refuse service to anyone whose pet is NOT considered suitable to the serenity/safety of our guests or the Campground.

Firearms & Fireworks: The use of firearms, air guns, BB guns, sling shots, or fireworks of any kind is prohibited. Please keep these items securely stored in your camping unit or vehicle.

Alcohol/Marijuana/Smoking: We are a family campground. All alcoholic beverages and marijuana must be consumed responsibly and are not allowed off your campsite. **Smoking is prohibited in play areas and all buildings.**

Refunds: There will be no refunds after you have checked in, for inclement weather, failure to follow the Rules & Regulations or disorderly conduct. Manager/Owner reserves the right to have discretion on all refunds.

General Liability: Guest hereby waives, releases and discharges and covenants not to sue Kritters Campground for all claims and liability for personal injury, accidents, property damage, any other claim arising out of or in connection with Guests' use of the Rental/Property. Further, Guest agrees to defend, indemnify, and hold harmless Kritters Campground from all losses, claims, expenses and demands, including attorneys' fees, that Kritters Campground may incur arising out of or in connection with Guests' use of the Rental/Property. Guest further agrees to be responsible and liable for the actions and safety of every person in their group. Kritters Campground reserves the right to remove any renter, occupant or guest who is subject to a lifetime registration requirement under a State sexual offender registration program.
